Make a Bequest... It's easy!

Remembering Maluk Timor Australia in your Will is a very real way you can help meet the health needs of thousands of people who have very few options. It also provides a way to make a significant gift that you may not find possible during your lifetime.

A Bequest is a gift that is either named or is anonymous. Put simply, it is an instruction contained within your Will that reserves part of your Estate for a particular beneficiary.

Your Will ensures your hard work, everything you have worked for in your lifetime, is passed on to those you love and to the causes close to your heart.

A Bequest is personal, and by making a provision in your Will for Maluk Timor Australia, you are creating an enduring legacy that helps to ensure a better health system in Timor- Leste.

All Bequest gifts are important, whether large or small. Usually a Bequest is directed to general purposes. That means, its use is at the discretion of the Board of Maluk Timor Australia. As unencumbered gifts, general Bequests provide flexibility for the funds to be directed to those areas which the Board and executive staff assess as being the greatest need at that time.

Maluk Timor Australia provides funds and governance for its sister organisation Associaço Maluk Timor, commonly referred to simply as 'Maluk Timor'.

Some of the key projects that your Bequest to Maluk Timor could support are:

- Infectious diseases
- Women's health initiatives
- Medical training
- Tuberculosis
- HIV
- Rheumatic heart disease
- Nursing
- Nutrition

Your Bequest is your choice

If you already have a Will, adding a Bequest for Maluk Timor Australia, either now or in the future, is simple.

Ask your legal advisor to assist you in making the changes to your current Will, or they can assist you in preparing a codicil form.

If you do not have a Will, consult a suitably qualified legal adviser (e.g. solicitor) to prepare a Will and have them note Maluk Timor Australia as a beneficiary.

There are quite few ways in which you can make your gift through your Will. Some of the options used by people who choose to make a Bequest include:



A percentage or proportion of an estate



A whole estate



Property



Stocks or shares



A specified amount of money



Works of art, collections or jewellery



The proceeds of a life insurance, annuity or trust

To make the appropriate change to your Will, the right words are required to make sure that your wishes are clear and can be clearly carried out. Here are some examples of wording that you can choose from.

Option 1

A Percentage Of Your Estate

I GIVE AND BEQUEATH to MALUK TIMOR AUSTRALIA (ABN 54 121 715 446) of Level 14, 60 Martin Place, Sydney 2000 (Maluk Timor) for its general purposes* *(insert percentage in words and figures)* percent of my estate, after payment of all my just debts and funeral and testamentary expenses and probate, estate or other duties payable out of my estate or in consequence of my death free and clear of all duties. I declare that the receipt of a director or other authorised officer of Maluk Timor shall be sufficient discharge to my executor.

* If there is a specific purpose (and not a general purpose), it should be noted here.



Option 2

A Specific Gift Of Property

I GIVE AND BEQUEATH to MALUK TIMOR AUSTRALIA (ABN 54 121 715 446) of Level 14, 60 Martin Place, Sydney 2000 (Maluk Timor) to be applied by Maluk Timor in such a manner as its directors may determine my *(insert description of gift)*. I declare that the receipt of a director or other authorised officer of Maluk Timor shall be sufficient discharge to my executor.



Option 3

A Fixed Amount

I GIVE AND BEQUEATH a legacy in the sum of *(insert amount in words)* to MALUK TIMOR AUSTRALIA (ABN 54 121 715 446) of Level 14, 60 Martin Place, Sydney 2000 (Maluk Timor) to be applied by Maluk Timor in such a manner as its directors may determine. I declare that the receipt of a director or other authorised officer of Maluk Timor shall be sufficient discharge to my executor.
